FINAL NOTICE

WHEREAS, the Jammu and Kashmir Services Selection Board vide Notification No. 01 of 2012, Item No. 057 advertised 03 posts of Lab Assistant "Health and Medical Education Department, Division Cadre Kashmir in OM category under Hon'ble Prime Minister's Special Package for Kashmiri Migrants, and

WHEREAS, as per indent/Advertisement Notification the prescribed qualification for the post is "**Matric with Diploma in Lab Assistant Training Course from SMF or any other any recognized institute**", and

WHEREAS, the Board shortlisted 15 candidates @ ratio 1:5 out of the candidates who qualified written test to be called for Viva Voce, and

WHEREAS, the Selection List comprising two candidates was forwarded to the Indenting Department vide this office communication No. SSB/Secy/Sel/2017/5389-95 dated 09.06.2017, however, the slot at S.No. 03 of the Selection List was kept unfilled /blank with regard to clarification for consideration/non-consideration of 03 years Diploma programme in Medical Laboratory Technology form SBOTE; and

WHEREAS, the Board vide communication No. SSB/Sel/Secy/2017/227 dated 21.02.2017 requested the Commissioner/Secretary to the Government Health and Medical Education Department Civil Secretariat, Jammu to clarify that whether "03 years diploma in Programme in Medical Laboratory Technology" from Directorate of Technical Education can be considered for selection for the post of Lab Assistant or otherwise, and

WHEREAS, in reply to the letter dated 21.02.2017, the Health and Medical Education Department vide letter No. HD/NG/79/2017 dated 19.07.2017 forwarded a letter from Director, State Board of Technical Education J&K, demanding therein recognition which clearly indicates that they are not recognized from SMF and have also mentioned to go ahead with the selection process as per Recruitment Rules, and





WHEREAS, as per the decision of 140th Board meeting the matter was taken up with the Indenting Department vide Communication No. SSB/Sel/Secy/2018/10592-93 dated 16.10.2018, in response to this letter the Indenting Department advised to go ahead with the selection for the post of Lab Assistant as per the qualification mentioned in the Indent which is **"10+2 with diploma Lab Technician from any recognized institute"**, and

WHEREAS, the candidate namely Samvit Dhar falling in waiting at S.No. 01 in OM category approached the Hon'ble High Court by filling writ petition bearing SWP No. 481/2019 titled Samvit Dhar Vs State of J&K and Others, which has been disposed of by the Hon'ble Court on 14.03.2019, and

WHEREAS, the Health and Medical Education Department vide communication No. HD/Legal/NG/MR/33/2019 dated 21.01.2020 advised to fill the post of Lab Assistant strictly as per Indent/Recruitment Rules. The Health and Medical Education Department further conveyed that there is no binding for not considering the candidate who diploma in Medical Laboratory Technology from J&K SBOTE, and

WHEREAS, the Board decided in the 163rd Board meeting held on 19.02.2020 to release the recommendation in favour of the candidate by issuing a speaking order, subject to the condition that the indenting Department shall conduct proper verification of recognition status of diploma candidate (s) produced by the candidate from the State Para Medical Nursing Council, and

WHEREAS, the Board constituted a committee vide order No. 226-SSB of 2020 dated 09.09.2020 for examining the instant matter and furnish appropriate report/recommendation, and

WHEREAS, the said Committee examined the case and reported that the merit list/Selection List needs to be re-drawn as per the prescribed qualification mentioned in the Indent/advertisement notification i.e. **"Matric with Diploma in Lab Assistant Training Course from SMF or any other any recognized institute"**, and

WHEREAS, the matter was placed before the Board in its 178th meeting held on 10.01.2021, the Board considered all the facts placed before it and decided to issue speaking order regarding issuance of Selection List as per the prescribed qualification mentioned in Indent/Advertisement.


