
1/ Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) notified final select list of the candidates for the post of "**Junior Staff Nurse**" (Health & Medical Education Department), (GMC Baramulla), Divisional Cadre Kashmir, item No. 08/2019/002 and recommended the same to the Health and Medical Education Department vide letter No. SSB/Secy/Sel/K/43/2538-44/2020 dated 02.04.2020; and

2/ Whereas, the recommendation in respect of candidates namely Sabreena Gull D/o Mohd Abdullah Shah and Safiya D/o Ghulam Nabi Giloo figuring at S.No. 08/OM and 31/OM respectively was kept withheld on account of obtaining certain clarifications; and

3/ Whereas, the aforesaid candidates were served three (03) notices vide this office No. SSB/ Secy/ Sel/43/ 2020/K/3423-25 dated 22.09.2020, No. SSB/Secy/Sel/43/2020/K/4485-87 dated 03.12.2020 and No. SSB/Secy/Sel/43/2020/K/1443-45 dated 16.02.2021 for furnishing the requisite documents within a period of 21 days, 10 days and 07 days respectively (a copy of which was uploaded on the official website of the Board), however they preferred not to submit the same for considering release of their withheld recommendation; and

4/ Whereas, the matter was considered by the Board in its **182<sup>nd</sup>** Board meeting wherein it was decided that the candidature/selection of the above said candidates be cancelled so that the deserving candidates against the post of "**Junior Staff Nurse**" in the Waiting list get a chance to be considered for employment.

5/ Now, therefore, in the view of the facts and circumstances narrated herein above, the candidature of the candidates namely Sabreena Gull D/o Mohd Abdullah Shah and Safiya D/o Ghulam Nabi Giloo figuring at S.No. 08/OM and 31/OM respectively for the post of "**Junior Staff Nurse**" (Health & Medical Education Department), (GMC Baramulla), Divisional Cadre Kashmir, item No. 08/2019/002 is cancelled/ withdrawn ab-initio and the indenting department is requested to operate the waiting list, if required, in accordance with extant norms.
