TERMS & CONDITIONS

1. The applicant at the time of filling of application form will submit self declaration form of being domicile in terms of the J&K Grant of Domicile Certificate rules 2020, as per enclosed format.
2. Selected candidates will have to submit the J&K - UT domicile certificate issued by competent authority, at the time of joining.
3. Applications can be rejected by the screening committee if found not falling as per required criteria.
4. Contract will be offered by District Health Society, Bandipora and not by the J&K Government.

5. The initial contract will be for a period up to 31-03-2022, extendable subject to performance review of the selected candidates, budgetary provisions in the next financial year and continuation of Scheme.
6. The selected candidates shall be paid monthly honorarium under National Health Mission, as communicated by State Health Society J&K and contractual hiring shall not be entitled to any other allowances or monetary benefits whatsoever.
7. A contractual appointee shall have to execute an agreement/bond with District Health Society Bandipora.
8. Only recognized degrees and diplomas shall be considered for eligibility.
9. The Candidature of the appointed candidates shall be cancelled in case at any stage it is found that he or she concealed any fact or submitted fraudulent certificates or misrepresented the facts to avail the candidature.
10. The number of posts may increase or decrease depends on the vacancy which may arise during the process of selection.
11. The expression block used in this advertisement would mean Medical Block, not CD Block certified by the concerned Block Medical Officer.
12. Candidates already working under NHM against the advertised posts in the district cannot apply.
13. The contractual appointee shall be required to work at the place against the post to which he/she is appointed and shall not be eligible for transfer from the place of posting.
