The Jammu & Kashmir Services Selection Board conducted the Computer Based Test (CBT) and based on the performance of the candidates, the Board, vide Notification No. SSB/COE/CBT/2022/2311-17 dated 07.03.2022, published the result/score sheet of the candidates for the said post. 
The Selection List, as mentioned above, shall be subject to outcome of the writ petition (s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.


