Whereas, the J&K Public Service Commission, vide Notification No.09-PSC (DR-P) of 2021 dated 03.09.2021, invited online applications from the applicants who are domiciled in the Union Territory of Jammu and Kashmir, for 10 posts (OM=05, RBA=01, SC=01, ST=01, EWS=01 & ALC/IB=01) of Assistant Professor, History in Higher Education Department. In response, the Commission received 327 application forms; and,

Whereas, Rule 45(i) of J&K Public Service Commission (Business and Procedure) Rules, 2021, as amended from time to time, provides that weightage to be given to the academic performance (to be worked out on prorata basis) for the post of Assistant Professor and its equivalent in Higher Education Department is as under:-

Whereas, Rules 45 of J&K Public Service Commission (Business and Procedure) Rules, 2021, as amended from time to time, further provides for shortlisting of the candidates to be called for interview in the ratio of 1:3. As such, 15 candidates in OM category, 03 candidates in RBA category, 03 candidates in SC category, 03 candidates in ST category, 03 candidates in EWS category, and 03 candidates in ALC/IB category are to be provisionally shortlisted for interview on the basis of academic performance as recorded in the documents submitted by the candidates; and,

Whereas, after compilation of the data with respect to the above given weightage points and the ratio to be adopted for short-listing of candidates for interview, **the cut off merit under the categories of OM, RBA, SC, ST, EWS, & ALC/IB, is 42.43, 43.08, 32.73, 33.11, 32.50 & 36.05 respectively.**
