Consequent upon the receipt of indent/requisition from the Culture Department, vide Indent No. Cul/Gen/38/2020/Vacancy dated 29.09.2020, and No. Cul/Gen/38/2020 dated 03.12.2020, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts, advertised 01 post of Library Assistant in OM Category, vide Notification No. 04 of 2020 dated 16.12.2020, under Item No. 62.


The Selection List shall also be subject to the outcome of any inquiry, involving candidate(s), figuring in this Selection List.
