Whereas, the J&K Public Service Commission, vide Notification No.02-PSC (DR-P) of 2022 dated 06.01.2022, invited online applications from the domiciles of UT of Jammu & Kashmir, possessing the prescribed qualification, for 01 post, under Open Merit category of Lecturer/Assistant Professor Kayachiktsa (Medicine) in Government Ayurvedic Medical College-cum-Hospital, Akhnoor, in Health & Medical Education
