
Whereas, in response to the ibid notification, the Commission received 11 application forms in the said discipline; and,

Whereas, in Notification No.02-PSC (DR-P) of 2022 dated: 06.01.2022, it was expressly mentioned that the provisions of allied subject have been earmarked in case the Candidates of Post Graduate qualification in the concerned subject are not available.

Now, therefore, in view of the above, the candidature of the above listed applicants is hereby rejected. If any of the applicant feels aggrieved with rejection of his/her candidature, he /she may represent before the Appellate Authority of the Commission in support of his/her claim within 10 days from the date of issuance of this Notice. No claim whatsoever shall be entertained after the stipulated period.
