Subject:-Rejection of the candidature for the post of Programmer in Skill Development Department.

Whereas, the J&K Public Service Commission, vide **Notification No. 06-PSC (DR-P) of 2022 dated 24.1.2022**, invited online applications on the prescribed format from the Domiciles of Jammu & Kashmir(UT) possessing the prescribed qualification for two posts, one each under OM and RBA category of Programmer in Skill Development; and

Whereas, the eligibility/method of recruitment for the post is as under:

"Bachelor Degree in Engineering with 55% marks in appropriate branch of Engineering (Computer Science and Engineering) or Equivalent from a recognized University"


Whereas, the written examination was conducted w.e.f. 14.11.2022 to 18.11.2022, and the result was declared vide Notification No. PSC/Exam/2022/39 dated 19.12.2022, in which 10 candidates were declared to have qualified for interview/viva voce; and

Whereas, it was clearly stipulated in the result notification that only eligible candidates, possessing requisite qualification under rules, shall be allowed to appear in the oral test/ viva-voce; and

Whereas, after scrutiny of the application forms, 03 candidates with following roll numbers have been found ineligible for the post of Programmer for not possessing the requisite qualification.
