## Notification No. 19-(DR-S) of 2023

**Dated: 12.05.2023**

Whereas, the Department of Law, Justice & Parliamentary Affairs, vide letter No. Law-Estt/29/2022-10 Dated: 01.04.2022 and LD(Estt)2019/51 dated:21.01.2020, referred thirty eight (38) posts of ALR/DLO, as per the following break-up, to the J&K Public Service Commission, for being filled up in accordance with the relevant rules of the Department:

Whereas, the J&K Public Service Commission advertised the said posts vide Notification No.21- PSC (DR-P) of 2022 dated: 29.08.2022 read with addendum dated: 02.09.2022; **and,**

Whereas, in response to the above notification, 1985 applications were received; **and,**

Whereas, in pursuance of Rule 43 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended from time to time, a written test was conducted on 22.01.2023, in which 1474 candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam (S)/2023/06&PSC/Exam (S)/2023/07 dated 08.02.2023, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examinations) Rules, 2022 read with Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended from time to time. 121 candidates were called for interview; **and,**

Whereas, vide IMPORTANT NOTICE dated 19.01.2023, all the candidates who had applied for the post of Assistant Legal Remembrancer/District Litigation Officer in response to the said Notification were who informed that the Commission has not verified the documents of any candidate before the written Examination and has decided to allow all the candidates to appear provisionally in the said examination. Any candidate found ineligible in any manner after verification of documents, his/her candidature shall be deemed to be have been rejected ab- initio. Mere appearance in the examination shall not confer upon him/her any right for consideration even he/she may have fared well; **and,**

Whereas, the viva-voce of candidates who had qualified the written exam, was conducted w.e.f 03.04.2023 to 08.04.2023 & on 11.04.2023 with the assistance of Experts; **and,**

Whereas, the provisional select list was notified vide Notification No 13-PSC (DR-S) of 2023 dated 13.04.2023 subject to objections, if any; **and,**

Whereas, the Commission received 14 representations against the provisional Select List; *and*,

Whereas, a committee was constituted vide Office Order dated 92-PSC of 2023 dated 28.04.2023 for examination of the representations; *and*,

Whereas, the Commission, inter alia, took the following decisions in its meeting dated 04.05.2023:


The report of the Committee constituted vide Office Order No. 92-PSC of 2023 dated 28.04.2023 regarding consideration of representations received against the provisional Select List was placed before the Commission. The Commission after detailed deliberations keeping in view the Recruitment Rules, Judgement of Hon'ble High Court in case Tahir Ahmad Dar V/s State, J&K Public Service Commission (Business & Procedure) Rules, 2021 and the conditions contained in the advertisement Notification took the following decisions:

- A. "Wherever there is an overlap between Higher Qualification and the experience, the experience gained during the pursuit of such higher qualifications be subsumed towards eligibility and points wherever awarded to such overlapped higher qualification be deducted."
- B. "The documents which have been issued within cut of date and were valid/uploaded with the online application form can only be entertained. In case any document which was not valid/uploaded with the online application form but was presented later on cannot be entertained. Therefore any candidate awarded points for such document or held eligible on the basis of such document shall neither be entitled for such points nor be eligible on the basis of such document."
- C. "The documents of all the candidates be crosschecked before release of final recommendation and discrepancies, if any, be brought to the notice of the Commission for further decision."

Whereas, the Commission further directed that once the Select List will be finalized, these candidates, whose candidature is rejected or points are deducted from the score, shall be given an opportunity of being heard before the final orders are passed.

Whereas, after further crosschecking, a Select List comprising 29 candidates was approved by the Commission for recommending to the Department for appointment.

Consequent upon the above, the Select List of the candidates is given as Annexure to this Notification.
