Whereas, a written test was conducted on 25.05.2023. The result of the written test was declared vide Notification No. PSC/Exam(s)/2023/29 dated: 26.06.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date. Thirteen candidates were called for interview; **and,**

Whereas, the viva-voce of candidates was conducted on 08.07.2023, with the assistance of Expert.

Now, therefore, on the basis of the performance in the written test, interview and other related parameters, in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.
