**Subject: Service Review of AGMUT Cadre IPS Officers under Rule 16(3) of AIS (DCRB) Rules, 1958.**


The undersigned is directed to refer to UT Division, MHA OM No. 14016/08/2018-UTS.I dated 05.04.2023 on the subject inter alia recommending premature retirement of Shri Basant Kumar Rath, IPS (AGMUT: 2000) in public interest under Rule 16(3) of the All India Services (Death-Cum -Retirement Benefits) Rules, 1958.

2. The Central Government, after careful consideration of the proposal of the UT Division and the performance of Shri Basant Kumar Rath, IPS (AGMUT: 2000) has come to the conclusion that the officer is not fit to be retained in service in public interest. The Central Government has, therefore, decided to retire Shri Basant Kumar Rath, IPS (AGMUT: 2000) prematurely from service, in public interest, under Rule 16(3) of the AIS (DCRB) Rules, 1958 with immediate effect.

3. Therefore, the order in respect of Shri Basant Kumar Rath, IPS (AGMUT: 2000) is enclosed which may please be immediately served on the concerned officer. As per rules, the officer is to be paid a sum equivalent to the amount of his pay plus allowances for a period of three months, calculated at the same rate at which he was drawing immediately before his retirement. Hence, cheques of requisite amount may be prepared by the UT Division, MHA and handed over to the officer alongwith the order to be served on him.

4. The date on which the order is served on Shri Basant Kumar Rath, IPS (AGMUT: 2000) along with the three months' pay and allowances may please be intimated to this Ministry promptly. A copy of the notification issued by the UT Division prematurely retiring Shri Basant Kumar Rath, IPS (AGMUT: 2000) from service in public interest may also be forwarded to this Ministry.
