(ii)	Matriculation DOB Certificate.
(iii)	10+2 Marks Certificate.
(iv)	Domicile Certificate.
(v)	Valid Category Certificate, wherever applicable.
(vi)	Unmarried certificate, in case of female candidates, falling under reserved categories.
(vii)	Other documents as prescribed under advertisement notice.
(viii)	One passport size recent colour photograph.
(ix)	One original photo-ID Proof i.e. Aadhar Card/Voter ID Card/PAN Card/Passport etc.

- 3. Candidates who fail to appear for document verification on the scheduled date shall forfeit their candidature for the post of Nursing Aid (G-III).
- 4. The provisional shortlist has been prepared on the basis of information provided by the candidates while submitting their online application forms and merit obtained by them in the written examination and is subject to further verification/scrutiny of documents/credentials/details filled in the application forms.
- 5. Candidates may note that deficiency, if any, with regard to the basic eligibility as prescribed in the advertisement notice found at any stage shall render him/her in-eligible for the post of Nursing Aid G-III and his/her candidature shall stand cancelled irrespective of the merit obtained by him/her in the written examination.
- 6. Any candidate found guilty of impersonating or submitting fabricated/tampered documents/testimonials or making false, incorrect or suppressing material information shall render him/her liable for criminal prosecution. Also canvassing/lobbying in any form will entail disqualification of the candidate.

7. The shortlisting and subsequent selection is subject to outcome of any writ petition pending before the Hon'ble Court of Law.
