Subject: Provisional Select List for the post of Assistant Professor, History, in Higher Education Department – disposal of representation thereof.

Whereas, Higher Education Department, vide letter No. HE/Coll/Coord/Apptt/A.P./2021 dated: 05.07.2021 and HED-GAZ/85/2022-04 dated: 13.04.2022, referred ten (10) posts (OM: 05, RBA: 01, SC: 01, ST: 01, EWS: 01, ALC/IB: 01) of Assistant Professor (History) to the J&K Public Service Commission, for selection; *and,*

Whereas, the J&K Public Service Commission, vide Notification No. 06-PSC (DR-P) of 2023 dated: 01.03.2023, advertised the said posts; *and,*

Whereas, again, vide letter No. HED-GAZ/85/2022-04 dated: 24.03.2023, the Higher Education Department, referred four (04) posts (OM: 02, RBA: 01, PSP: 01) of Assistant Professor (History) to the J&K Public Service Commission for selection; *and,*

Whereas, the J&K Public Service Commission, vide Notification No. 17-PSC (DR-P) of 2023 dated: 15.05.2023, advertised the said posts; *and,*

Whereas, the written test was conducted on 27.08.2023 and the result of the written test was declared vide Notification No. PSC/Exam/S/2023/51 dated: 12.09.2023; *and,*

Whereas, the viva-voce of the candidates was conducted on 19th and 20th of September, 2023; *and,*


Whereas, the Select List was provisional, subject to objections, against which were to be received within five days; *and,*

Whereas, one representation has been received from Mr. Ghulam Haider Shah against the Provisional Select List wherein he has

stated that the Provisionally Selected Candidate Mr. Vishal Sharma has been selected under Notification No. 06-PSC (DR-P) of 2023 dated: 01.03.2023 under ALC/IB category with merit position of 66.38. The cut-off merit for open merit category in Notification No. 17-PSC (DR-S) of 2023 dated: 15.05.2023 is 65.69, Mr. Vishal Sharma may be shifted to open merit category and in his place the representee may be selected under ALC/IB category having secured 58.10 points in Notification No. 06-PSC (DR-P) of 2023 dated: 01.03.2023.

Whereas, the Commission conducted the examination for the posts referred vide Notification No. 17-PSC (DR-P) of 2023 dated: 15.05.2023 and 06-PSC (DR-P) of 2023 dated: 01.03.2023. The Notification No. 06-PSC (DR-P) of 2023 dated: 01.03.2023 was relating to vacancies notified by the Public Service Commission earlier to the Notification No. 17-PSC (DR-P) of 2023 dated: 15.05.2023. The Commission first fills up the vacancies notified by the Commission as indented by the department earlier, to the subsequent Notifications. Sh. Vishal Sharma has applied for the vacancies notified through first Notification and has been selected under ALC/IB category as per his merit. While filling up the vacancies for the second Notification i.e. 17-PSC (DR-P) of 2023 dated: 15.05.2023, Mr. Vishal Sharma is not available to claim for the second Notification as he has already been selected against the ALC/IB vacancy in the first Notification. Only left over eligible candidates are selected to fill up the vacancies of the second Notification.

Now, therefore, the representation is disposed of, being devoid of any merit, and is rejected.
