## NOTICE INVITING APPLICATIONS FOR THE ENGAGEMENT AS FULL TIME LEGAL AID LAWYERS IN LEGAL AID DEFENSE COUNSEL OFFICE IN DISTRICT JAMMU, KATHUA, UDHAMPUR AND GANDERBAL OF UT OF J&K UNDER J&K LEGAL SERVICES AUTHORITY.


The Legal Aid Defense Counsel System (LADCS) has been implemented in all the 20 districts of UT of J&K however in few District Headquarters some of the posts of Legal Aid Defense Counsels (LADCs) remained vacant either due to non-availability of suitable candidates or for want of candidates fulfilling the eligibility criteria. Moreover, in a couple of districts the LADCs have tendered their resignation for one or the other reason leaving the LADC office vacant.

Accordingly, applications are invited from eligible lawyers (for eligibility and other conditions please visit J&K LSA website <http://jkslsa.gov.in>) having requisite qualification for full time contractual engagement for the below mentioned posts shown against their respective districts given below;
