**Subject: Provisional Select List for the post of Assistant Professor,

Whereas, Higher Education Department, vide letter No. HE/Coll/Coord/APtt/A.P./2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.04.2022, referred **three (03) posts (OM: 01, RBA: 01, SC:01)** of **Assistant Professor, Electronics**, to the J&K Public Service Commission, for selection of suitable candidates; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 06- PSC (DR-P) OF 2023 dated: 01.03.2023, advertised the said posts for selection; *and*,

Whereas, again, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, the Higher Education Department, referred five (05) posts (**OM: 04, ST: 01**) of **Assistant Professor, Electronics**, to the J&K Public Service Commission, for selection of suitable candidates; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 17- PSC (DR-P) OF 2023 dated: 15.05.2023, advertised the said posts for selection; *and*,

Whereas, written test was conducted on 27.08.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/74 dated: 03.11.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; *and*,

Whereas, thirteen (13) candidates were called for interview against Notification dated 01.03.2023 and 22 candidates against Notification dated 15.05.2023. Six (06) were common candidates against both of the Notifications. As such, interview of 29 candidates only was conducted; *and*,

Whereas, the viva-voce of candidates was conducted on 7th of November, 2023, with the assistance of Experts from outside of the UT.


Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the

candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.


