Whereas, the Health & Medical Education Department, vide letter No. MEGztd/270/2022 dated 01.11.2022 referred two (02) posts under OM category of **Librarian** for GMC Handwara and Udhampur, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission, vide Notification No. 30-PSC (DR-P) OF 2022 dated: 30.12.2022, advertised the said posts for selection; **and,**

Whereas, written test was conducted on 29.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/84 dated: 14.11.2023, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; **and,**

Whereas, 05 candidates qualified for interview against each post. However, since 03 candidates were common against the two posts, as such only 07 candidates were called for interview ; **and,**

Whereas, the interview/viva-voce of candidates was conducted on 17.11.2023 with the assistance of Expert from outside of the UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 43(II) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the details given here-in-above, Provisional Select List of the candidates as per merit, is given in **Annexure-B** to this Notification.

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The Selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
