Whereas, you appeared in the Examination held for the said posts, under Roll No.1080200, and have secured total Score of **81.68** under Open merit; and


Whereas, among other candidates, you were shortlisted for Document Verification/Supplementary Document Verification, conducted by the J&K SSB for the said posts; and
