

Subject: Declaration of Final Result of Head Constable (Ministerial) in Delhi Police Examination, 2022.

The Staff Selection Commission declared the result of the Computer Based Examination (CBE) on 28.12.2022 for shortlisting the candidates to appear in Physical Endurance and Measurement Test (PE&MT)/Document Verification.

2. The Delhi Police had conducted PE&MT/DV of the shortlisted candidates in CBE. The summary of the result of PE&MT and Document Verification is as under: -

3. Thereafter, Skill/ Trade Test of the candidates qualified in the PE&MT was conducted in two parts by the Delhi Police. Result of the "Typing Test on Computer", which was conducted from 17.10.2023 to 19.10.2023, was declared by the Delhi Police on its website on 28.11.2023. Further, the Computer Formatting Test, which is qualifying in nature, was also conducted by the Delhi Police from 04.12.2023 to 06.12.2023 only for those candidates who were shortlisted in "Typing Test on Computer". The summary of the result of Skill/Trade Test is as follows: -

4. As per Para 10.1 of the Notice of the Examination, the candidates possessing NCC Certificate have been granted incentive/bonus marks as follows: -

- NCC 'C' Certificate: 5 % of the maximum marks of examination
- NCC 'B' Certificate: 3 % of the maximum marks of examination
- NCC 'A' Certificate: 2 % of the maximum marks of examination

5. Allocation of candidates for final result and reserve panel have been done on basis of marks of Computer Based Examination (Normalised Marks), NCC incentive/bonus and marks of Typing Test on Computer.

7. As per the provisions under Para No. 26 of the Notice of the Examination, in the event of tie in scores of candidates, such cases have been resolved by applying following criteria, one after another in the given order, as applicable, till the tie is resolved: -

- (i) Date of Birth, with older candidates placed higher.
- (ii) If the date of birth is also same, the candidate with higher marks in Computer Based Examination placed higher.

- (iii) If date of birth and marks in Computer Based Examination are also same, the candidate with higher marks in Typing Test placed higher.
- (iv) If date of birth, marks in Computer Based Examination and marks in Typing Test are also same, then in accordance with alphabetical order of the names of candidates.
8. Pursuant to provisions under Para 27 of the Notice of the Examination, a 'Reserve Panel' of 15% candidates has also been prepared. The 'Reserve Panel' will be maintained and operated by the Delhi Police.
9. Any discrepancy with respect to the shortlisted/ not-shortlisted candidates in the final result may be brought to the Notice of the Commission within a period of one month. Any such representation received after one month will not be entertained by the Commission.
10. The marks of the shortlisted/ not-shortlisted candidates in the final result will be made available on the website of the Commission in due course.
