- vi) Registration Certificate from J&K Medical Council/CCIM, or an undertaking by the candidate(s) as mentioned in Notification No.100-BOPEE of 2023 dated 23-10-2023.
- vii) Valid Identity Card (Passport, Aadhar Card, Pan Card, Driving License etc.)
- viii) Any other document as may be required by the College.

It shall be sole responsibility of the concerned Colleges/Institutions to ensure proper check and verification of documents / eligibility as per the guidelines issued by Ministry of Ayush, New Delhi, before the candidate is allowed for admission and in case of any discrepancy in the requisite eligibility / documents, the same shall be reported to the Board for further course of action under rules.

In order to complete the admission process within the prescribed cut-off date, the concerned College / Institution shall keep its admission counters open even on holidays/off days to facilitate the candidates to complete their admission process well in time. However, the candidates should in their own interest avoid waiting for the last day to complete admission formalities since delay has the potential of causing hardships to the candidates only.
