Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 23 posts among other posts of Election Department vide Advertisement Notification No. 04 of 2020 dated 16.12.2020 and the cut-off date, i.e., the last date for applying for the aforementioned posts and for determining the eligibility/academic qualification and validity of category certificates and other such documents of the candidates which may be required as per indent was **31.01.2021**; and

Whereas, as per the Notification, the selection to these posts was to be made on the basis of Written Examination only and, accordingly, the JKSSB conducted the OMR Based Test for these posts on 08.10.2023 and, thereafter the JKSSB notified result of candidates for the said posts vide Notification No. JKSSB/CoE0EXAM(UT)/76/2023-03(7291629) dated 13.10.2023; and

Whereas, on the basis of merit obtained by the candidates, the Document

Verification was conducted vide Document verification Notice No. JKSSB/CoEOEXAM(UT)/76/2023-03(7291629) dated 13.10.2023, on 20.10.2023, both at Jammu and Srinagar, by the DV Committees constituted vide Order No. 227-SSB of 2023 dated 13.10.2023, followed by the Supplementary DV which was conducted vide Notification No. JKSSB/COEOEXAM(UT)/76/2023-03(7291629) dated 20.10.2023 on 25.10.2023; and

Whereas, a Selection Committee for preparing the selection to the aforementioned posts was constituted vide Order No. 240-SSB of 2023 dated 25.10.2023; and

Whereas, keeping in view the afore-stated facts, the selection committee prepared the Provisional Selection list, which was approved by the Board in its 245th Board Meeting held on 15th November, 2023, and subsequently notified vide Notification No. JKSSB/SEL/SECY/2023/1060-69 dated 21.11.2023: and

Whereas, the candidate/s aggrieved with this Provisional Selection were asked to represent through the email address deoikssb2023@gmail.com within three days from the date of Notification of the Provisional Selection List, the representations so received have been examined in light of the rules on the subject; and

Whereas, in response to letter No. JKSSB-Sel/Secy/2023-1127 Dated 20.12.2023, the Election Department vide its letter No. CEO-EsttOAF/1/2022-1/3556 Dated 29-12-2023, has provided a clarification that:

"...the case of equivalence regarding the eligibility criterion of the selected candidate needs to be taken up with the Skill Development Department which will take some time to receive the same and will be conveyed separately once received from the concerned quarter.

It has been suggested to release the select list of rest of the candidates who fall within the selection zone withholding the selection of that particular candidate in view of requirement of Data Entry Operators for upcoming Lok Sabha elections..."

Whereas, in view of the above clarification, the recommendation of one candidate namely Mr. Altaf Hussain Wani (DV No 1 ADD DV KMR) has been kept withheld; and

Whereas, the Hon'ble Central Administrative Tribunal, Jammu Bench, in the O.A. No. 61/1476/2023(JAMMU), titled Sushil Kumar V/s UT of J and K and ors, in its order dated 10.11.23, had directed that

"...the Original Application is disposed of at the admission stage, without entering into the merits of the case with a direction to respondents to treat a copy of this Original Application as representation of the applicant and decide the same by passing a reasoned and speaking order. While taking a decision in the matter, the respondents should also consider the judgments of Hon'ble Supreme Court, Hon'ble High Court of Jammu and Kashmir and orders of this Tribunal annexed with the Original Application. The applicant shall also be afforded an opportunity of hearing. The whole exercise shall be undertaken within a period of four weeks from the date of receipt of a certified copy of this order."

Whereas, in view of the above directions the candidate namely Mr. Sushil

Kumar (DV No. 02 JMU) was afforded an opportunity of being heard by means of a notice issued vide Notice No. JKSSB-LEG/364/2023-03(E-7334501) dated 01.01.2024, in response to which the candidate submitted his representation on 03.01.2024, at central office JKSSB Jammu. The matter was deliberated in the Board in its 253rd Board meeting, whereafter a consideration order was passed vide No. 09 SSB of 2024 dated 05.01.2024, wherein the claims of the candidate were found to be devoid of any merit; and

Whereas, the Board in its 253rd Board Meeting held on 05.01.2024, after deliberations/consideration of representations and in view of the aforementioned clarification, approved the Final Selection List for the 23 posts of **Data Entry Operator**, advertised under Item No. 098 (UT Cadre, Sub-Department/Appointing Authority-Chief Electoral Officer, J&K) of Election Department, vide Advertisement Notification No. 04 of 2020 dated 16.12.2020.

Now, therefore:

- (i) The Final Selection List for 23 posts of **Data Entry Operator**, advertised under Item No. 098 (UT Cadre, Sub-Department/Appointing Authority- Chief Electoral Officer, J&K) of Election Department, vide Advertisement Notification No. 04 of 2020 dated 16.12.2020, is hereby notified as **Annexure-A** to this Notification.
- (ii) The Selection List shall be subject to the outcome of writ petition(s)/OAs, if any, pending in any Court of Law of the competent jurisdiction.
- (iii) The List shall also <u>be subject to the outcome of pending inquiry</u>, if any, involving candidate(s), figuring in this Selection List.
- (iv) The formal recommendations to the Indenting Department shall be made separately.
