On the recommendations of the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of following candidates as Library Assistant in Higher Education Department in the Pay Level-2 (19,900-63,200) with immediate effect.

The appointees shall report to Director Colleges J&K within a period of twenty one (21) days from the date of issuance of this order and if anyone fails to join within the stipulated time, shall forego their right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- Academic/Qualification Certificates.
- Matriculation/Date of Birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate issued by the Competent Authority.

- v. That if the candidate has taken loan for self employment from DIC /Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- vi. Valid relevant Category Certificate, if any applicable.
- vii. Any other certificate required under rules.

The appointment of the above candidates shall further be subject to the following conditions:

- a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointees or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.
- b. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment as (Library Assistant) shall be deemed to have cancelled ab-initio and the legal action as warranted under rules shall be initiated against him
- c. The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agencies.
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f. The inter-se-seniority of the appointee shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
- h. In case of any certificate found fake/ incorrect, the appointment of the candidate shall be taken to have been cancelled ab-initio.

- i. The appointees shall furnish an Undertaking in the shape of an Affidavit as per Annexure-A to this Order;


