
Whereas, the J&K Services Selection Board has issued Notification for the Selection list of Class-IV posts earmarked for Physically Challenged Candidates (Sub-category of Deaf & Hard of Hearing), advertised vide Notification No. 01 of 2020 dated 26.06.2020 and forwarded to the same to the GAD under Letter No. JKSSB/55/2022-05 (7048574) dated 28.07.2023; and

Whereas, among the selected candidates, the recommendation of various candidates was kept withheld subject to production of valid disability certificate and all relevant documents; and

Whereas, the JKSSB issued a Notice, vide No. JKSSB/55/2022-05 (7048574) dated 10.01.2024 & dated 12.01.2024 to such candidates whose recommendation were kept withheld and advised them to submit the requisite documents/ valid Disability Certificates within 07 days; and

Whereas, despite the lapse of considerable time, the candidates did not submit the requisite Certificates and, accordingly, the above withheld cases were placed in the 260th Board Meeting, which, taking note of the fact that despite sufficient time/opportunities afforded to these candidates, they have failed to produce the requisite document (Valid Disability Certificate) and, accordingly, decided to cancel their withheld recommendation.

Now, therefore, and in view of the above, the withheld recommendations of the candidates, as per **Annexure-A** to this communication for the post of Class IV, advertised vide Notification No. 01 of 2020 dated 26.06.2020 are hereby **cancelled**.
