

Whereas, the Provisional official answer key was notified and uploaded on the official website of the Commission for information of the candidates on 17.03.2024, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification, i.e upto 20.03.2024 (5:00 p.m.) along with documentary proof /evidence alongwith the fee of Rs. 500/- per question; and
3. Whereas, in response to the said notification, nine (09) representations were received by the J&K Public Service Commission against Provisional Answer Key; and
4. Whereas, the objections/representations were referred to the Committee of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time for Independent Expert opinion; and
5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Answer Key in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the independent team of Experts, it is hereby notified that:-



- a) The changes recommended by the Committee of Experts are hereby adopted and the Final Official Answer Key is annexed to this notification;


