Consequent upon the receipt of indent/requisition from the Health and Medical Education department, vide indent No. HD/Drug/24/2020 dated 25-09-2020 followed by No. HD/Drug/24/2020 dated 07.01.2021. and No. ME/NG/83/2020 dated 08.03.2021 and No. HD/Coord/64/2020 dated 25.09.2020 and No. HD/Coord/63/2020 dated 25.09.2020 and No. HD/ISM/62/2020 dated 25.09.2020 and No. HD/Coord/64/2020 dated 05-03-2021 and No. ME/NG/83/2020 dated 28.09.2020, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts, advertised the 15 posts of "**Laboratory Assistant**", Divisional Cadre, Kashmir, "**Junior Laboratory Technician**", Divisional Cadre, Kashmir, of Health and Medical Education Department, Advertisement no. 02 of 2021 dated 26.03.2021, under **item Nos. 222** and **228** respectively, with the following breakup:

The Provisional Selection List was prepared by the selection committee on the basis of the principle of Merit-cum-Preference, which was approved by the Board in its **221<sup>st</sup> Board Meeting** held on 14.03.2023 and subsequently notified vide Notification No. **JKSSB/Sel/Secy/2023/412-21 dated 20.03.2023** and the candidate/s aggrieved with this Provisional Selection were asked to represent through the email.

Consequently, the Board in its 227<sup>th</sup> Board Meeting, after deliberations/consideration of representations and objections so received, on the **Provisional Selection List**, approved the **Final Selection List** for the aforementioned 15 posts, among other posts of the domain and notified it vide notification No. **JKSSB/Sel/Secy/2023/655-64 dated 25.05.2023**.



Accordingly, the undersigned forwarded the selection list, for the aforementioned 15 posts, among other posts vide communication No.JKSSB/Sel/Secy/2023/684-88 dated 01.06.2023.

The wait list in the instant selection was not forwarded along with the select list, as per Regulation 68 of The Jammu and Kashmir Service Selection Board (Business and Procedure) Regulations, 2022, which provides that in respect of the Combined Selections the Board has to maintain a category-wise Combined Waiting List with it and forward the same to the Indenting Department as and when requested by it. Also, as the practice of drawing up and forwarding the wait lists was discontinued owing to the issuance of S.O. 496 dated 26.09.2023, which omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof.

Also, vide S.O. 134 dated 28.02.2024, the earlier omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, has again been added to the mentioned rules, to which the effect has been given retrospectively, i.e., from 26.09.2023 (the date of the omission of the said sub-rule) and also vide S.O. 137 dated 28.02.2024, the Board was directed to draw up wait list(s), in respect of those select list(s) which have been issued after 07.09.2023, within a period of six-months, subject to the following conditions; namely:

- (i) That such wait list(s) are drawn within the validity period of the select lists; and
- (ii) That the resultant vacancies on account of non-joining of selected candidates have not been re-advertised.

The Health and Medical Education Department vide communication No. ME-NG/348/2023-02 (CC:7214798) dated 20.05.2024, respectively forwarded the requisition for the posts of "**Laboratory Assistant**", Divisional Cadre, Kashmir, "**Junior Laboratory Technician**", Divisional Cadre, Kashmir, under item No. 222 and 228, respectively, as per the vacancy position received from Administrator, Associated Hospitals, Srinagar, vide communication No. AH/MC/Est-II/2023/5751 dated 11.11.2023, wherein the details of selection/appointment/joining and non-joining of the incumbents for the aforementioned posts was compiled and submitted to the indenting department. The same had been requisitioned to the indenting department as per the table below:



The Selection of the candidates in the wait list has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.
