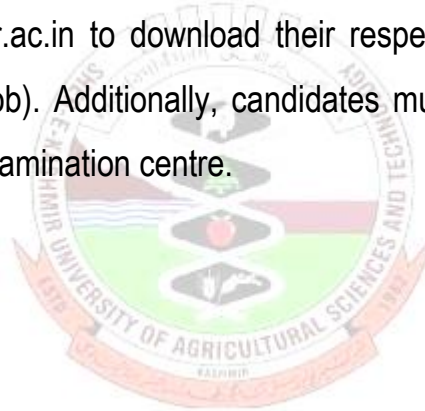




NOTICE






