Subject: Waiting List for the posts under Item No. 164 (Laboratory Technician, Divisional Cadre, Jammu) and Item No. 177 (Senior Laboratory Assistant, Divisional Cadre, Jammu of Health and Medical Education Department, Advertisement no. 02 of 2021 dated 26.03.2021.

Notification

Whereas, the Health and Medical Education department, vide indent No. HD/Drug/24/2020 dated 25-09-2020 followed by No. HD/Drug/24/2020 dated 07.01.2021. and No. ME/NG/83/2020 dated 08.03.2021 and No. HD/Coord/64/2020 dated 25.09.2020 and No. HD/Coord/63/2020 dated 25.09.2020 and No. HD/ISM/62/2020 dated 25.09.2020 and No. HD/Coord/64/2020 dated 05-03-2021 and No. ME/NG/83/2020 dated 28.09.2020, among other posts, forwarded the requisition for making direct recruitment to the 20 posts under two items as per the following break up:

Whereas, as per the Indent, the qualification prescribed for the posts was (is) as under:

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 20 posts, among other posts of Health and Medical

Education Department, vide Advertisement Notification No. **02 of 2021 dated 26.03.2021**; and

Whereas, as per the Notification, the selection to these posts was to be made on the basis of Written Examination only and, accordingly, the JKSSB conducted the Computer Based Test (CBT) for these posts in multiple sessions/slots w.e.f. **17.08.2021 to 25.08.2021**; and

Whereas, on the basis of merit obtained by the candidates in the written test, the Document Verification was conducted in terms of Notice No. **SSB/CoE/Health/2021/7598-7606** dated **09.11.2021**, from **20.11.2021 to 04.12.2021**, by the DV Committees constituted vide Order No. **380-SSB of 2021** dated **17.11.2021** followed by Order No. **386-SSB of 2021** dated **18.11.2021** and Order No. **389-SSB of 2021** dated **18.11.2021**; and

Whereas, DV in respect of left out candidates was conducted from **18.10.2022 to 19.10.2022** by committee constituted vide Order No. **348-SSB of 2021** dated **30.11.2021**; and

Whereas, the candidates figuring in the consideration zone for the above mentioned posts were allowed to indicate the order of preference for various posts/items through a link provided on the official website of the Board at **www.jkssb.nic.in** from **17.11.2021** upto **25.11.2021**, vide Notice No **SSB/CoE/Health/2021/7695-7704** dated **17.11.2021**, that was extended upto **30.11.2021** vide Notice No **SSB/COE/Health/2021/7958-67** dated **25.11.2021**; and

Whereas, the selection committee for preparing the selections to the aforementioned posts was constituted vide order no **344-SSB of 2021** dated **29.11.2021**, that was superseded by the constitution of a committee vide order no **277-SSB of 2022** dated **8.10.2022**; and

Whereas, the matter was in the Hon'ble Central Administrative Tribunal against the said selection process in the case of Hilal Ahmad Bhat and others vs UT of J&K and others case, wherein, the Hon'ble CAT Srinagar clubbed TA No. 5646/2021 and TA No. 221/2021, that were disposed of by way of a common order on 15.11.2022 with the following directions:

" In view of the above discussion, it is clear that the applicants are governed by the rules of 2009 which clearly state that the engagement of applicants was on academic arrangement basis for a period of one year extendable upto a maximum of six years or till selection is made in accordance with the recruitment rules. The applicants had also executed an agreement/contract with the respondents that they will not claim for regularization of their services, The respondents were well within their jurisdiction and competence to issue the advertisement notification 02 of 2021 dated 26.03.2021. With these observations, TA 5646/2021 and TA 221/2021

along with all the MAs are dismissed. All the interim orders stand vacated. The respondents are at liberty to proceed further to complete the process of selection and appointment of candidates as per advertisement notification No 02 of 2021 dated 26.03.2021. No order as to costs"

Whereas, the petitioners, aggrieved of the final order of Hon'ble CAT Srinagar mentioned above, approached the Hon'ble High Court of J&K and Ladakh, wherein the **Hon'ble High Court of Jammu & Kashmir and Ladakh** at Srinagar in WP(C) No. 2682/2022, while pronouncing its Judgement on 31.01.2023, upheld the decision of **the Hon'ble Central Administrative Tribunal, Srinagar Bench** and maintained that:

"In view of the above and having regard to clear position of law enunciated by the Supreme Court in Uma Devi (3), we fully concur with the view taken by the CAT, Srinagar Bench. We find no merit in these petitions and the same are, accordingly, dismissed. The interim directions, if any, shall stand vacated. The respondents are free to conclude the selection process initiated vide advertisement Notice No. 02 of 2021"

Whereas, upon receiving the aforementioned directions from the Hon'ble High Court of Jammu & Kashmir and Ladakh on 31.01.2023, the selection committee so constituted prepared the provisional selection list, by following the principle of *Merit-cum-Preference*, that was notified vide Notification No. JKSSB/Sel/Secy/2023/412-21 dated 20-03-2023; and

Whereas, the Board in its 227th Board Meeting, after deliberations/consideration of representations and objections received on the **Provisional Selection List**, approved the **Final Selection List** for the aforementioned 20 posts among other posts of the domain and notified it vide notification No. **JKSSB/Sel/Secy/2023/655-64 dated 25.05.2023**.

Whereas, the select list was forwarded to the Health and Medical Education Department vide communication No. JKSSB/Sel/Secy/2023/684-88 dated 01.06.2023; and

Whereas, the wait list in the instant selection was not forwarded along with the select list, as per regulation 68 of The Jammu and Kashmir Service Selection Board (Business and Procedure) Regulations, 2022, which provides that in respect of the Combined Selections the Board has to maintain a category-wise Combined Waiting List with it and forward the same to the Indenting Department as and when requested by it. Also, as the practice of drawing up and forwarding the wait lists was discontinued owing to the issuance of S.O. 496 dated 26.09.2023, which omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof; and

Whereas, vide S.O. 134 dated 28.02.2024, the earlier omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, has again been added to the mentioned rules, to which the effect has been given retrospectively, i.e., from 26.09.2023 (the date of the omission of the said sub-rule) and also vide S.O. 137 dated 28.02.2024, the Board was directed to draw up wait list(s), in respect of those select list(s) which have been issued after 07.09.2023, within a period of six-months, subject to the following conditions; namely:

- (i) That such wait list(s) are drawn within the validity period of the select lists; and
- (ii) That the resultant vacancies on account of non-joining of selected candidates have not been re-advertised.

Whereas, The Health and Medical Education Department vide communication No. ME-NG/178/2024-02(CC: 7448575) dated 22.04.2024 and 24.04.2024, respectively forwarded the requisition for the posts of "**Laboratory Technician**", Divisional Cadre, Jammu, "**Senior Laboratory Assistant**", Divisional Cadre, Jammu, under item No. 164 and 177, respectively, as per the vacancy position received from Principal Government Medical College, Jammu vide communication No. AHJ/2024/11441-11442 dated 22.03.2024, wherein the details of selection/appointment/joining and non-joining of the incumbents for the aforementioned posts was compiled and submitted to the indenting department. The same has been requisitioned as per the table below:


