Whereas, the J&K Services Selection Board, vide Indent No. ASHF-CORD/92/2021-03 dated 04.04.2022, received the requisition for **15 posts of Deputy Inspector/ Equivalent,** from Animal/Sheep Husbandry & Fisheries Department, which were advertised by the Board vide Notification No. 04 of 2022 dated 27.07.2022, under Item Nos. 143 and 144, as per the following category-wise break up:

Whereas, the requisite qualification for selection against these posts, as per the Indent/ advertised, was mentioned as under:

"B.Sc. Medical (Zoology) or B.Sc. Industrial Fish & Fisheries from a recognized University/Institute."

Whereas, Animal/ Sheep Husbandry and Fisheries Department, vide letter No. SHF-CORD/92/2021-03 dated 10.08.2022, conveyed that the prescribed qualification for the post of Deputy Inspector/ Equivalent as per Recruitment Rules of the J&K Fisheries (Subordinate) Service notified vide SRO No.296 dated 10.10.2008 is as under:

"B.F.Sc. or B.Sc. Medical (Zoology) or B.Sc. Industrial Fish & Fisheries from a recognized University/Institute".

Whereas, the Board issued a corrigendum vide Notification No. SSB/Secy/Advt. No. 04/2022/5903-20 dated 05.09.2022, regarding the prescribed

qualification for the 15 posts of Deputy Inspector/ Equivalent advertised under Notification No. 04 of 2022 dated 27.07.2022, as under:

"B.F.Sc. or B.Sc. Medical Zoology or B.Sc. Industrial Fish & Fisheries from a recognized University/Institute".

Whereas, the cut-off/last date for applying for these posts, and for determining the eligibility of the candidates for purpose of educational/category and other benefits was **20.09.2022**. The OMR based Written Examination for selection against these 15 posts of Deputy Inspector/ Equivalent, was conducted by the JKSSB on 03.03.2024; and

Whereas, the Board, vide Notification No. No. JKSSB-COEOEXAM(UT)/3/2024-04 (7407286) dated 14.03.2024, notified the Result/Score-sheet of the OMR based Written Examination held for these posts. This was followed by the Document Verification of the candidates falling in the consideration zone w.e.f. 26.03.2024, both at Jammu and Srinagar, which concluded with Supplementary DV on 02.04.2024; and

Whereas, vide Office Order No. 187-SSB of 2024 dated 14.05.2024, a Selection Committee was constituted for preparing the Selection List for these posts. The said Selection Committee, upon careful scrutiny of the Indent/ advertisement, prepared the Provisional Selection List for these posts in accordance with the merit and eligibility of the candidates as per the extant rules; and

Whereas, the Provisional Selection List, as prepared by the aforesaid Selection Committee for these posts of Deputy Inspector/ Equivalent, Animal/Sheep Husbandry & Fisheries Department, was placed before the Board in its 274th meeting held on 05.06.2024, which, after due deliberations and consideration of the matter, approved its notification; and

Whereas, the Provisional Selection List for the aforesaid 15 posts of Deputy Inspector/ Equivalent, Animal/Sheep Husbandry & Fisheries Department, was accordingly, notified vide No. JKSSB-Scry/13/2024-03(E-7479276) dated 10.06.2024, seeking objections from the candidates. In the Provisional Selection List, a total of 04 cases were kept withheld for various reasons; and

Whereas, pursuant to the above, various representations were received in the Board, pertaining broadly to submission of documents w.r.t. withheld cases, correction in

particulars etc., which were examined as per the available record/ extant guidelines, for necessary action; and

Whereas, the proposal for notifying the Final Selection List, for the aforesaid 15 posts of Deputy Inspector/ Equivalent, Animal/Sheep Husbandry & Fisheries Department, advertised vide Notification No. 04 of 2022 dated 27.07.2022, as prepared by the concerned Selection Committee, was placed in the Board in its 276th meeting held on 25.06.2024, which after due deliberation on various aspects related to the instant selection, approved its notification.

Now, therefore, the Final Selection List of the candidates for 15 posts of Deputy Inspector/ Equivalent, Animal/Sheep Husbandry & Fisheries Department, advertised vide Notification No. 04 of 2022 dated 27.07.2022, under Item Nos. 143 and 144, is hereby notified as per **Annexure-A** to this Notification. It is further notified that:

- i. The Final Selection List shall be subject to outcome of the OAs/Writ Petition(s), if any, pending in the competent court of law.
- ii. The List shall also be subject to the *outcome of any pending enquiry*, involving any candidate(s), as figuring in this list.
- iii. The formal recommendations of the concerned Indenting Department shall be forwarded separately.
- iv. The candidate whose recommendations are kept withheld shall submit the requisite documents/ certificate within a period of one month.
- v. The Selection of the candidates has been made on the basis of Self-declaration/ certificates submitted by them and if at any stage, it comes to light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/ certificates, the selection shall be liable to cancellation at any stage.
