Applications through online mode are invited from eligible candidates for engagement as **Assistant Professors ((contractual))** on academic arrangement in the following subjects:

Subject	Eligibility
English	Master's degree with 55% marks (or an equivalent grade in a point-scale) in English from an Indian University, or an equivalent degree from an accredited foreign university AND NET/SLET/SET or Ph. D.
Civil Engineering	B.E. / B. Tech/ B.S. and M.E. / M. Tech./ M.S. or integrated M. Tech. in relevant branch with 1 st class or equivalent in any one of the degrees OR Ph.D. from institution of National importance with GATE/GPAT/CEED directly after the Bachelor's degree.
Electrical Engineering	

I. Emoluments:

- PG : Rs. 45,000/- per month
- NET/SLET/SET : Rs. 48,000/- per month
- Ph. D. : Rs. 50,000/- per month
- NET/SLET/SET and Ph.D. : Rs. 50,000/- per month

II. Tenure

The tenure of contract shall be for current academic session, 2024, or till the post is filled on permanent basis whichever is earlier.

III. Leave

As per University norms applicable.

IV. How to Apply:

The eligible candidate can apply online and deposit fee of Rs. 300/- online and submit the downloaded application form and supported by attested copies of all relevant documents, certificates, and testimonials in the **Concerned Department of IUST** on any working day by or before the last date (except Saturday/ Sunday/ holiday) for submission of hardcopies, failing which the online application form submitted by the candidates shall not be considered.

V. Selection process:

The selection of a candidate shall be based on academic merit calculated as per UGC regulations 2018 (Table:3. A) and interview in ratio of 50:50. In case, the number of applications is more, the interview shall precede by shortlisting which shall be done on the basis of academic merit calculated as above.

VII. Important Notes:

1. The applications shall have to be submitted through the University portal www.iust.ac.in under the specified tab.
2. Candidates will have to produce original documents relating to their qualification, experience etc. at the time of appearing in the interview.
3. No TA/DA shall be paid to candidates for appearing in the interview.
4. Only post qualification experience shall be considered.
5. Eligible candidates will be informed about the date and place of interview through University website / e-mail/ whichever suitable. However, University does not take any responsibility for non-receipt or delayed receipt of the intimation by a candidate.
6. Candidates who have been awarded postgraduate/Ph. D degree from Foreign University should enclose "Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi without which their candidature will not be considered, and application form will be rejected.
