
The terms & conditions/reference for counselling shall be as under:-

1. The candidates are required to attend, on their own expenses the Counselling on stipulated date/time and venue, failing which their candidature for provisional selection/admission shall not be considered in spite of having superior claim/merit.
2. The seats shall be filled strictly as per prescribed eligibility in order of merit in UET -2024
3. At the time of allotment of seat during the Counselling, the candidates shall have to pay in full & on-spot the prescribed semester/annual fee, as the case may be excluding Hostel Fee
4. In case a candidate fails to deposit the requisite prescribed Semester/Annual fee, as the case may be, in full at the time of Counselling, he /she shall forfeit the selection /admission and the seat so forfeited shall be offered to the immediate next candidate in order of merit.

5. Mere presentation of a candidate for Counselling, if called for, shall not confer upon him/her the right to selection/admission unless otherwise eligible.
6. No Under Process Certificate in respect of any requisite document shall be entertained/accepted under any circumstance
7. The candidate(s) who did not attend the document verification on the scheduled dates can get their documents verified on the dates of counselling notified above such candidates shall to report SKUASAT-K, Shalimar by **8:45 A.M** positively
