- Any other relevant document may be asked for submission. Keep two sets of photocopied documents along with the original documents readily available.

Note: Mere submission of the above-mentioned documents doesn't imply that the candidate is eligible for the post. In case of any dispute, the decision of the Principal, Govt. Medical College, Kathua shall be final.

Candidates will be required to produce relevant certificates as mentioned above in original also as proof of having acquired the prescribed educational qualification on or before the cut-off date fixed for walk-in interview, failing which the candidature of such candidates shall be cancelled by the selection committee. No representation/ request for change in interview date or timing shall be entertained, whatsoever be the reason.
