Whereas, the J&K SSB vide above letter dated 04.06.2024, took-up the matter with Director, Sainik Welfare Board in respect of Rajiv Singh S/o Suram Chand who was selected for the post of Junior Assistant in Sainik Welfare Department (Home) and in return vide letter No. 357-Estt/Rect/DSW/2024/1117 dated 14.06.2024, the Director Sainik Welfare Board, has furnished their reply in respect of Rajiv Singh S/o Suram Chand.

Whereas, the case was accordingly, placed in the 287<sup>th</sup> Board Meeting held on 25.10.2024, alongwith the clarification provided by the Director Sainik Welfare, which **decided to cancel the withheld recommendation of ESM candidate, Rajiv Singh S/o Suram Chand due to ineligibility of the candidate for the post of Junior Assistant.**
