Kashmir), Animal/Sheep Husbandry and Fisheries Department, advertised vide Notification No. 04 of 2021 dated 17.07.2021-release of waiting list thereof reg.

NOTIFICATION

Whereas, the Animal/Sheep Husbandry and Fisheries Department, vide Indent No. ASH/Coord/24/2014 dated 29.09.2020, among other posts, forwarded the requisition for making direct recruitment to **42 posts of Deputy Inspector Fisheries/Equivalent**, as per following details:

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised these 42 posts, pertaining to Divisional Cadre, Jammu (10 Posts) and Divisional Cadre, Kashmir (32 Posts), vide Notification No. 04 of 2021 dated 17.07.2021, under Item Nos. 656 and 657 respectively, for seeking applications from the eligible candidates; and

Whereas, in terms of the notified selection criteria, the selection for these posts was required to be made on the basis of the written examination only and accordingly, the JKSSB conducted the Computer Based Test (CBT) on 08.02.2023, in two shifts and on the basis of the performance of the candidates in the aforesaid CBT, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/06/2023-04(7110979) dated 09.06.2023, published the Result/Score-sheet of the candidates.

This was followed by the Document Verification (DV) of the candidates falling in the consideration zone, vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03(7207093) dated 20.06.2023 and Supplementary Document Verification vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03(7207093) dated 18.07.2023.

Whereas, the Board, vide letter No. JKSSB-Scry /18/2023-03(7325184) dated 09.01.2024, has forwarded the Selection List for the post of Deputy Inspector Fisheries/Equivalent (Level 4; Item No. 656: Div Jammu; Item No. 657: Div Kashmir, Divisional Cadre posts), Animal/Sheep Husbandry and Fisheries Department, advertised vide Notification No. 04 of 2021 dated 17.07.2021 Agriculture Production Department for further course of action; and





Whereas, the Agriculture Production Department J&K vide letter No. ASHF-FISHONGAZ/26/2023 (7343099) dated 19.07.2024 requisitioned that one post of Deputy Inspector Fisheries/ Equivalent has remained unfilled due to non-joining of Sh. Chander Kant, who was figuring at S. No. 17 in ESM/OM category (Divisional Cadre Kashmir) as the said appointee didn't join the department despite last and final opportunity given to him vide Order No. 262-Fisheries of 2024 dated 03.07.2024.

Furthermore, in light of S.O. 134 of 2024 dated 28.02.2024, the provisions for drawing the waiting lists have been revived and, accordingly, the selection Committee prepared the waiting list of the candidate for the aforementioned post, which was subsequently placed before the Board. The Board in its 287th meeting decided as under:

"The Board, having regard to the request of the Agriculture Production Department for furnishing the waiting list against the non-joining of one ESM/OM candidate in the Final Selection List notified for the posts of Deputy Inspector Fisheries/ Equivalent, Level-4; (Item No. 657: Div. Kashmir), Animal/Sheep Husbandry and Fisheries Department, advertised vide Notification No. 04 of 2021 dated 17.07.2021, decided that, as per the past precedence, the Waiting List for the post shall be prepared and notified in order of next in merit cum preference under OM category (Vertical category), for consideration against the non-joining of ESM/OM candidate."

Now therefore, after taking into consideration all the aforementioned factors, the waiting List as per extent norms has been prepared for the post of Deputy Inspector Fisheries/Equivalent, Level-4; (Item No. 657: Div. Kashmir), in the Animal/Sheep Husbandry and Fisheries Department, advertised vide Notification No. 04 of 2021 dated 17.07.2021 is hereby notified as per the **Annexure-A** to this Notification. It is further notified that:

1. The above waiting List shall be subject to outcome of the OAs/writ petition(s), if any, pending adjudication before any competent court of law.
2. The List shall also be subject to the outcome of such *enquiry*, involving any candidate(s), as figuring in this List.
3. Formal recommendation to the concerned Indenting Department shall be forwarded separately.
4. The Selection of the candidates has been made on the basis of Self-declaration/ Certificates submitted by him and if at any stage, it comes to the light that the candidate has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
