- 5. Applications not fulfilling the eligibility conditions or not accompanied by necessary valid supporting documents shall be rejected without any communication with applicant.
- 6. The selected candidate will not have any claim for the regular appointment either in PRC or in University of Kashmir, Srinagar. The University of Kashmir/PRC has no liability for either regularizing the services or offer regular appointment to the selected candidate.

The University/PRC reserves its right to limit the number of candidates to be called for Interview/written test and shortlisted candidates shall be informed about the date of interview or any screening test through email/phone only and the list of shortlisted candidates will be uploaded on PRC website.
