Subject: Filling up of the Reserved Posts in the Final Selection List notified vide Notification No. 21-Selection of 2024 dated 04.06.2024 for the post of Inspector Finance Department, (UT Cadre) advertised vide Notification No. 04 of 2020 dated 16.12.2020, under Item No. 117.

NOTIFICATION

Whereas, the Finance Department, vide Indent No. FD/Coord/08/2020 dated 20.11.2020, forwarded the requisition for making direct recruitment to **18 posts of Inspector**, which were put to advertisement by the Board vide Notification No. 04 of 2020 dated 16.12.2020, under Item No. 117, as per the following break up:

Whereas, the prescribed qualification for these posts is/was "**Graduation from any recognized University.**"

Whereas, in terms of the notified selection criteria, the recruitment against these posts was to be made in the following manner:

"Marks obtained in the written test out of maximum marks that shall be proportionately converted into points = 80, Viva Voce = 20, Total= 100."

Whereas, the JKSSB conducted the OMR based written examination for the said posts on **17.03.2024** and the Final Answer Key was notified. This was followed by the Document Verification-cum-Interview/Viva-voce of the candidates shortlisted vide Notice No. JKSSB-COE0EXAM(UT)/9/2024-03 (7430339) dated 15.04.2024; and

Whereas, the Interview Panel for holding the Document Verification-Interview/Viva Voce for the post of Inspector, Finance Department, UT Cadre, advertised vide Notification No. 04 of 2020 dated 16.12.2020 under Item No. 117, was constituted vide Office Order No. 180-SSB of 2024 dated 06.05.2024; and

Whereas, the Document Verification-Interview/Viva Voce for the instant post was held on 7th, 9th and 10th of May, 2024 in the Central Office, JKSSB, Srinagar/Jammu; and

Whereas, the Selection Committee for preparing the Selection List to the aforementioned posts was constituted vide Office Order No. 184-SSB of 2024 dated 09.05.2024; and

Whereas, a total of fifty-eight (58) candidates, falling in the consideration zone, were shortlisted for the Document Verification-cum-Interview/Viva Voce and all fifty-eight (58) candidates participated in it; and

Whereas, the Final Selection List for the above mentioned 18 posts, was approved by the Board in its 273rd Board Meeting and the recommendations were forwarded to the Indenting Department vide communication No. JKSSB-Scry/11/2024-03(E-7475024) dated 05.06.2024; and

Whereas, in the said forwarded list 01 slot was kept reserved under OM/ESM category subject to the outcome of the O.A. 569/2024 titled Ragubir Singh Vs UT of J&K and Others; and

Whereas, the Hon'ble CAT Jammu dismissed the said O.A. No: 569/2024, imposed penalty on the petitioner and passed the direction to the Board that:

"...The official respondents are at liberty to fill up the posts of Inspector Finance UT Cadre in ESM category as per rules."

Whereas, the matter was deliberated in the Board in its 294th Board Meeting held on 10.01.2025 and it was decided to fill up the post of "Inspector, Finance Department" advertised vide Advertisement No. 04 of 2020 dated 16.12.2020, under Item No. 117 under OM/ESM category with the candidature of the candidate who was already figuring in the Provisional Selection List under Selection Category OM/ESM.

Now, therefore, it is hereby notified that:

- (i) The candidate figuring in **Annexure-A** shall figure against the reserved posts (at the serial as indicated) in the Final Selection List notified for the post of Inspector Finance Department, (UT Cadre) advertised vide Notification No. 04 of 2020 dated 16.12.2020, under Item No. 117.
- (ii) The above selection of the candidates shall be subject to outcome of the OAs/Writ Petition(s), if any, pending adjudication before any Competent Court of law and shall also be subject to the outcome of any pending *enquiry*, involving candidate(s).
- (iii) The formal recommendations to concerned Indenting Department shall be forwarded separately.
- (iv) The candidate(s) whose recommendations are kept withheld shall submit the requisite documents/certificates within a period of one month.
- (v) The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes

to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
