Subject: Assigning responsibilities of Migrant Colonies/Transit Camps

Government Order No.:62-JK(GAD) of 2025 Dated:14.01.2025

In continuation of Government Order No. 381-JK(GAD) of 2021 dated 28.04.2021, it is hereby ordered that following departments shall be responsible for providing services under their domain, in the migrant colonies/transit camps in Jammu and Kashmir Divisions:-

 Housing & Urban Development Department shall provide day to day sanitation facility viz. collection, transportation and disposal of garbage and refuse, at the following locations:

2. Department of Youth Services & Sports shall be responsible for the maintenance of all play grounds in migrant camps at Jammu and transit camps at Kashmir. The Department shall further be responsible for Physical Education activities like Mass Physical Display in various schools in the camp areas, promoting adventure sports, engaging children in extracurricular activities like dance, drama, painting, quiz and debates, Youth and Cultural Festivals and promoting Scouts & Guides activities. The Department shall also cater to the aspect of personality development of children in migrant camps at Jammu and transit migrant camps at Kashmir through Physical Education.

- Department of Floriculture shall develop the open spaces and undertake
 maintenance of existing parks in the migrant camps at Jammu and transit
 migrant camps at Kashmir, and also be responsible for implementation of
 various centrally sponsored schemes.
- 4. Urban Environmental Engineering Department (UEED) shall undertake planning, designing and construction of works of sewerage and drainage in transit migrant camps, and deal with issues of public health, such as water borne diseases, waste water management, waste disposal, industrial hygiene and environment sustainability, to protect the population from the effects of adverse environmental factors and from potentially deleterious effects of natural and human activities:

 Jammu & Kashmir Energy Development Agency (JAKEDA) shall cover the entire gamut of renewable energy resources in the migrant camps, like installation and maintenance of solar lights and promotion/implementation of schemes of the Ministry of New & Renewable Energy (MNRE), Government of India. Department of Rural Development and Panchayati Raj shall develop critical rural infrastructure in transit/migrant camps in rural areas, and promote skill development programmes to enhance employ-ability and support rural entrepreneurship.

It is further ordered that the concerned departments shall nominate an officer (not below the rank of Executive Engineer) for liaising/coordinating the execution/maintenance of works/projects pertaining to their department with the Relief Organization (M) J&K.
