Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 02 posts, among other posts of Health and Medical Education Department, vide Advertisement Notification No. **02 of 2021 dated**

Whereas, as per the Notification, the selection to these posts was to be made on the basis of Written Examination only and, accordingly, the JKSSB conducted the Computer Based Test (CBT) for these posts in multiple sessions/slots w.e.f. **17.08.2021** to **25.08.2021;** and

Whereas, on the basis of merit obtained by the candidates in the written test, the Document Verification was conducted in terms of Notice No. **SSB/CoE/Health/2021/7598-7606** dated **09.11.2021**, from **20.11.2021** to **04.12.2021**, by the DV Committees constituted vide Order No. **380-SSB of 2021** dated **17.11.2021** followed by Order No. **386-SSB of 2021** dated **18.11.2021** and Order No. **389-SSB of 2021** dated **18.11.2021;** and

Whereas, DV in respect of left out candidates was conducted from **18.10.2022** to **19.10.2022** by committee constituted vide Order No. **348-SSB of 2021** dated **30.11.2021;** and

Whereas, the selection committee for preparing the selections to the aforementioned posts was constituted vide order no. **344-SSB of 2021** dated **29.11.2021**, that was superseded by the constitution of a committee vide order no. **277-SSB of 2022** dated **08.10.2022;** and

Whereas, the selection committee was further reconstituted vide order no. **09-SSB of 2025** dated **08.01.2025;** and

Whereas, keeping in view the aforementioned facts, the Provisional Selection list so prepared, by following the principle of *Merit-cum-Preference*; and

Whereas, the Provisional Selection List, as prepared by the aforesaid selection committee for the aforementioned posts was placed before the Board in its 293rd Board Meeting held on 26.12.2024, which, after due deliberations and consideration of the matter, approved its notification; and
