## University Order No: 01 (Secy.) of 2025 Dated: 09.01.2025

- Sub: 2<sup>nd</sup> Final Selection List of candidates for the post of Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner, and equivalent positions, after revisiting the merit of the candidates in the 2<sup>nd</sup> Provisional Selection List and upgrading the category candidates from the 1<sup>st</sup> Selection List to the Open Merit (OM) category.
  - Whereas, four (04) vacancies in Class-IV and equivalent positions, viz. Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner, etc., have arisen due to either non-joining of selected candidates or non-submission of verification rolls (V-rolls) by candidates listed in the 1st Selection List. Accordingly, University, vide Notification No. 337 (Secy.) of 2024 dated 14.08.2024, issued the 2<sup>nd</sup> Provisional Selection List of four (04) candidates next in merit for the aforementioned positions under the Open Merit (OM) category, as detailed below:

- Whereas, subsequently, University, received representations from the candidates belonging to reserved categories wherein they have contended that individuals already appointed to Peon and equivalent posts under the RBA and OSC categories, as per the 1<sup>st</sup> Selection List, should be considered for placement/upgradation in the Open Merit category based on their higher merit in comparison to the Open Merit candidates selected in the 2<sup>nd</sup> Provisional List. They further requested that the resultant vacancies, arising from such upgradation, be filled up amongst the eligible candidates from the RBA and OSC categories.
- Whereas, the Documents Verification-cum-Selection Committee was requested to revisit the merit list of candidates for the posts of Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner & equivalents and render its recommendations, in light of the claims raised by candidates in their representations.
- After a thorough review of the merit of candidates for Class-IV and equivalent positions, the Documents Verification-cum-Selection Committee gave the following recommendations in the said matter:
  - i) Two candidates, Sh. Aman Rathore and Sh. Amit Barna, initially selected under the RBA and OSC categories, respectively in the 1<sup>st</sup> Selection List for the post of Peon & equivalent, possess an overall merit ranking higher than the candidates listed at S.No. 2, 3, and 4 in the 2<sup>nd</sup> Provisional Selection List (issued by the University under No. 337 (Secy.) of 2024 dated 14.08.2024), be considered for an upgradation to the Open Category posts that have arisen due to nonjoining of the candidates in the 1<sup>st</sup> Selection List.

- ii) Consequently, the candidate at S.No 2 namely Ms. Rimpy Sharma in the 2<sup>nd</sup> provisional list be shifted down to S.No. 4 and candidates at S.No. 3 & 4 namely Sh. Abhishek Khajuria & Sh. Himanshu Singh, respectively be excluded from the 2<sup>nd</sup> provisional list.
- iii) Two candidates, namely Sh. Aabid Hussain Malik and Sh. Karnu Ram, who are next in merit under the RBA and OSC categories, respectively, are recommended for selection against the resultant vacancies that have arisen following the up-gradation of candidates listed at Serial No. 1 namely Sh. Aman Rathore and Sh. Amit Barna under the RBA and OSC categories, respectively in the 1<sup>st</sup> Selection List to the Open Category in the 2<sup>nd</sup> Provisional Selection List.

In light of the above recommendations, the 2<sup>nd</sup> Final Selection List of candidates for the post of Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner, and equivalent positions after revisiting the merit of the candidates in the 2<sup>nd</sup> Provisional Selection List and upgrading category candidates from the 1<sup>st</sup> Selection List to the Open Merit (OM) category in the 2<sup>nd</sup> Final Selection List, is hereby notified as per **Annexure-I**.

Consequent upon the above, the selected candidates (except upgraded candidates) are hereby informed to submit their email ID and contact details in the office of Registrar, SKUAST-Jammu in person or through email **registrarofficeskuastj@gmail.com** within a period of 10 days for uploading or registering the same on the Employees Verification System (EVS) portal for obtaining clearance of Character and Antecedents report from the Criminal Investigating Department (CID), failing which he/she shall forfeit his/her right for appointment.

The formal appointment order in favour of the selectees shall be issued separately only after obtaining clearance of Character Antecedent in his/her favour from the concerned department.
