3. APPLICATION FORM:

a. Applications are invited from the eligible candidates possessing prescribed qualifications for various non-faculty posts mentioned above purely on contract basis. Please fill the application carefully. Any amendment / rectification / change / editing is NOT allowed in Name / Date of Birth / Post applied / Category etc. Applicants may note that no correspondence will be entertained in this regard.

4. ELIGIBILITY NORMS:

- a. Cut-off date to determine the eligibility is last date of filling up online application form. To be eligible for selection for these posts, the candidate must have passed the qualifying degree examination & result should be declared to this effect on or before the last date of filling up of application form. Only such experience will be considered which is acquired after obtaining the qualifying degree/diploma, as applicable.
- b. Candidates who have been awarded degrees from foreign Universities / Medical Colleges should enclose "Equivalence Certificates" issued by the Association of Indian Universities, New Delhi / NMC, as applicable.
- c. It is the sole responsibility of the candidate to assess his / her own eligibility for the post for which he/she is applying in accordance with the prescribed qualification, experience etc. and submit his / her online application duly filled-in along with the desired information, documents and other supporting materials as per the advertisement. Suppression of factual information, supply of fake documents, providing false or misleading information or any other undesirable action by the candidate shall lead to cancellation of his candidature. - b. All candidates are advised to be alert and check AIIMS Jammu website www.aiimsjammu.edu.in regularly. - c. No TA/DA will be paid for attending the interview / applied tests or document verification joining the duty on selection etc.
- d. The candidate may have to work in shifts and can be posted at any place/department of the Institute.
- e. The candidate should not have been convicted by any Court of Law.
- f. The appointee shall be a whole-time employee of the Institute and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the contract period.
