After successful conduct of Driving Test, Written Examination and Document Verification, a Selection Committee was constituted to prepare Selection List for these posts.

Whereas, the designated Selection Committee framed the Final Selection List for these posts of Driver/Driver-II/Tractor Driver/Truck Cleaner, which was accordingly approved in the 266th Board Meeting and, notified vide Notification No. 20-Selection of 2024 dated 22.05.2024, which was subsequently, forwarded to Transport Department, vide letter dated 03.06.2024; and

Among others, one post of Transport Department under ALC/IB category for Item No. 121, was kept reserved for want of certain clarification, as the candidate who was otherwise figuring against the said post, failed to fulfil the deficiency. Accordingly, as per the decision of the Board the JKSSB vide Notification No. JKSSB-Scry/4/2024-03 (E-7411217) dated 07.05.2025, cancelled the candidature of Mr. Amit Mathur S/o Madan Lal whose post

was kept reserved for the post of Driver-II of Transport Department, advertised vide Notification No. 04 of 2022 dated 27.07.2022, under Item No. 121, UT Cadre.

Whereas, the Selection Committee Re-constituted vide Order No. 148-SSB of 2025 dated 14.05.2025, prepared the Final Selection List against the reserved post of Transport Department, under ALC/IB category for Item No. 121, advertised vide Notification No. 04 of 2022 dated 27.07.2022, by considering the candidate next in order of merit-cumpreference, as per norms and as decided by the Board in its 302nd Meeting.

Now, therefore, the reserved post under ALC/IB category in the selection notified for the posts of Driver-II, Transport Department, under ALC/IB category for Item No. 121, UT Cadre advertised vide Notification 04 of 2022 dated 27.07.2022, is hereby filled up by considering the candidature of Mr. Subash Chander S/o Parshotam Lal as per the details contained in "Annexure-A" to this Notification. It is further notified that:

- i. The above selection shall be subject to outcome of the OAs/Writ Petition(s), if any, pending in the competent court of law.
- ii. The List shall also be subject to the *outcome of any pending inquiry*, involving any candidate(s), as figuring in this list.
- iii. The formal recommendation of the concerned indenting department shall be forwarded separately.
- iv. The Selection of the candidate has been made on the basis of Self-declaration/ certificates submitted by him and if at any stage, it comes to light that he has submitted false information or has secured selection on the basis of fake or invalid documents/ certificates, the selection shall be liable to cancellation at any stage.
