I. Essential Qualification:

Eligibility A

i) Master's degree with 55% marks (or an equivalent grade in OGPA/ a point-scale wherever the grading system is followed) in concerned / relevant /allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Ph.D. degree (with course work) in concerned/ relevant /allied subject as prescribed by the UGC Minimum Standards and Procedure for Award of M.Phil / Ph.D. Degree) Regulations-2009 or the UGC Minimum Standards and Procedure for Award of Ph.D Degree) Regulations-2016 read with amendments thereto from time to time.

iii) National Eligibility Test (NET) conducted by UGC, ICAR, CSIR or a similar accredited State

Eligibility Test (SLET/SET).

A candidate who has been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 or 2016 read with amendments from time to time is exempted from NET/SLET/SET.

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Byelaws/Regulations of the Institution awarding the Degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor-cum-Junior Scientist or equivalent subject to the fulfilment of the following conditions:-

a. The Ph.D. degree awarded to the Candidate should be in a regular mode only;

b. The Ph.D. thesis should be evaluated by at least two external examiners;

c. An open Ph.D. viva voce of the candidate should have been conducted;

d. The candidate should have published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;

e. The candidate should have presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/ funded/ supported by the UGC/ICSSR/CSIR/ICAR or any Government Agency /PSUs

(a) to (e) above have to be certified by the Registrar or the Dean (Academic

Affairs) of the University concerned

iv) NET/SLET/SET shall not be required for the candidates in such disciplines for which NET/SLET/SET is not conducted by the ICAR, UGC and CSIR.

Eligibility B

The Ph.D degree of the candidate should be from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

(i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

The candidate's ability for teaching, research and extension aptitude shall be assessed through a seminar/lecture in a classroom situation or discussion during the interview.

Minimum Desirable Skills & Experience:

- 1. Knowledge: Should posses' adequate knowledge of basic theoretical and applied aspects of the discipline as evidenced by outstanding academic performance indicators.
- 2. Communication: Should be an effective communicator for instructional responsibilities of academic courses as evidenced by teaching and extracurricular assignments
- 3. Teaching: Should be well versed with the NEP-2020 and its application to Agricultural Education. Should have outstanding skills of student engagement and mentoring towards building a competent human resource pool. Trained in modern teaching pedagogies and content development.
- **4. Scholarly output:** Should possess strong science communication skills evidenced by high impact publications in reputed scientific journals, higher h and i-10 index.

General Terms & Conditions

- The engagement shall be purely temporary on academic arrangement basis till the culmination of the current Academic Year/Semester (whatever applicable) or till the post is filled up on regular basis, whichever is earlier.
- Monthly remuneration shall be paid to the selected candidates as per the University Order No. 262 (Est.) of 2025 dated 02.05.2025, from the date of his/her physically joining the place of posting till the date of completion of the term of engagement.
- The performance shall be evaluated periodically and in case of unsatisfactory or under performance, the contractual engagement shall be terminated without any notice.
- The engaged person shall have no right to claim extension or regular appointment or absorption in SKUAST-K service merely on the basis of having rendered contractual service on academic arrangement basis.

 of the engagement as Contractual/ Guest Lecturer and if found so, the engagement
