- i. All the candidates appearing for Document Verification/Counselling shall have to deposit a non-refundable Counselling fee of Rs 1000/- through Net Banking or other means of online transaction in the Account No. 0242040100004249 - SB of Comptroller SKUAST-K.
- ii. The selected candidates shall have to pay the prescribed fee of the 1<sup>st</sup> semester of the degree programme for which banking facility shall be available at the venue. The details of fee structure is given as under:-

### Terms & Conditions:

- The candidates are required to attend, on their own expenses, the Document Verification/ Counselling on stipulated date/time and venue, failing which their candidature for provisional selection/admission shall not be considered in spite of having superior claim/merit.
- The seats shall be filled strictly as per prescribed eligibility in order of merit (percentile/Score) obtained by the candidate in JEE Mains.
- The candidates shall have to pay the prescribed semester fee excluding Hostel Fee in full at the time of counselling/admission.
- In case a candidate fails to deposit the requisite prescribed Semester fee in full at the time of Counselling, he /she shall forfeit claim to the selection /admission and the seat so forfeited shall be offered to the immediate next candidate in order of merit.
- Mere appearing of a candidate for Document Verification/ Counselling, shall not confer upon the candidate any right to selection/admission unless otherwise eligible.
- If any candidate fails to submit valid reserved category certificate at the time of counselling, He/ She will be considered under Open Merit category, if otherwise eligible and no under process Certificate shall be entertained/accepted under any circumstance
