

Whereas, the J&K Services Selection Board (JKSSB), vide Notification No. JKSSB-Scry/14/2024-03 (E-7508166) dated 30.04.2025, notified the Waiting List for the posts of Stock Assistant, Divisional/District Cadres, Jammu/Kashmir, under various Item No.s 641, advertised vide Advertisement Notification No. 04 of 2021 dated 17.07.2021 and Notification No. 04 of 2022 dated 27.07.2022, respectively, of Animal/Sheep Husbandry and Fisheries Department and forwarded the recommendation of the selected candidates to the Indenting Department vide communication dated 02.05.2025; and

Whereas, among the selectees, the recommendation of candidates namely **Mr. Rajat Gupta**, S/o Sagar Chand R/o 14, 4, Kohag, Kohag, Duggain, Billawar, Kathua, 184203, **figuring at Sr. No. 1/EWS category**, under **Item No. 650**, Advertisement Notification No. 04 of 2021 dated 17.07.2021 was kept withheld subject to production of valid within date EWS certificate, as per format and candidate namely **Mr. Ramandeep Singh**, S/o Gurmeet Singh, R/o 4, Rangreth near gurdwara, Budgam, 191132, **figuring at Sr. No. 01/EWS category** under **Item No. 688**, Advertisement Notification No. 04 of 2021 dated 17.07.2021 was kept withheld subject to production of valid within date EWS certificate, as per format; and

Whereas, the aforementioned candidates failed to produce the requisite valid within date EWS certificates and accordingly the withheld recommendation cases were placed in the 306th Board Meeting, in which the Board took note of the fact that despite sufficient time/opportunities afforded to two candidates namely Mr. Rajat Gupta, S/o Sagar Chand and Mr. Ramandeep Singh, S/o Gurmeet Singh, the candidates have failed to produce the requisite document(s) (valid within cut-off date EWS certificate) and, accordingly decided to cancel their withheld recommendation.
