Kindly refer to this office letter No. JKSSB-Scry/3/2024-03 (E-7402474) dated 22.05.2025, where-under the Waiting List of candidates for the posts of Panchayat Secretary, Department of Rural Development & Panchayati Raj, District Cadre was notified vide Notification No. JKSSB-Scry/3/2024-03 (E-7402474) dated 17.05.2025 pursuant to Advertisement Notification No. 03 of 2022 dated 26.05.2022, under Item No. 064 (District Cadre, Baramulla), Item No. 073 (District Cadre, Doda), and forwarded to your department for further course of action.

Among others, the cases of 02 candidates, whose recommendations were kept withheld for the aforesaid posts, were placed before the Board in its 306<sup>th</sup> Board Meeting, which decided to release their recommendations on account of the deficiencies being cleared by the candidates.

Accordingly, the undersigned is directed to convey the above decision of the Board regarding the release of withheld recommendations of the candidates as figuring in "Annexure-A" to this communication for the posts of Panchayat Secretary, Department of Rural Development & Panchayati Raj, pursuant to Advertisement Notification No. 03 of 2022 dated 26.05.2022, under Item No. 064 (District Cadre, Baramulla) and Item No. 073 (District Cadre, Doda), with the request to kindly proceed ahead in the matter accordingly. The other terms and conditions, as conveyed vide letter No. JKSSB-Scry/3/2024-03 (E-7402474) dated 22.05.2025, shall remain the same.

The above recommendations shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Selection List shall also be subject to the outcome of any inquiry, involving candidate(s) figuring in this Selection List.




The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of the Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidates/s may kindly be initiated.

Moreover, in terms of Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
