"Graduate from recognized University having 65 words per minute speed in short hand and 35 words per minute speed in typing"

Whereas, the J&K Services Selection Board, conducted the type test and Short Hand Test for these posts for which the result was declared on 19.10.2024, and accordingly, the Written Examination (OMR based) of the successful candidates for the posts of Junior Scale Stenographer/Junior Stenographer was conducted on 31.12.2024. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/56/2023-03(7245177) dated 17.03.2025 published the Result/Score-sheet of the candidates; and

Whereas, after the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification both at Jammu and Srinagar on 11.04.2025, followed by supplementary Document Verification on 25.04.2025; and

Whereas, the JKSSB, vide Order No.162-SSB of 2025 dated 28.05.2025, a Selection Committee was constituted for preparing the Selection List for **05 posts** of Junior Scale Stenographer/Junior Stenographer, belonging to various departments; and

Whereas, the said Selection Committee, upon careful scrutiny of the Indents/advertisements, prepared the Provisional Selection List for the **05 Posts** in accordance with the Merit/ Eligibility and preference of the candidates as per the extant rules and same was placed in the board in its 307<sup>th</sup> meeting, held on 01.07.2025, which after due deliberations and consideration of the matter, approved its notification.

Whereas, pursuant to the above, only one representation was received in the Board, w.r.t. correction in particulars etc., which was examined as per the available record/ extant guidelines, for necessary action; and

Whereas, the proposal for notifying the Final Selection List, for the aforesaid **05 posts** of Junior Scale Stenographer/ Junior Stenographer of various departments advertised vide Notification No's 04 of 2021 dated 17.07.2021, 05 of 2021 dated 22.09.2021 and 02 of 2022 dated 09.02.2022, as prepared by the concerned Selection Committee, was placed in the Board in its 310<sup>th</sup> meeting held on 24.07.2025, which after due deliberation on various aspects related to the instant selection, approved its notification.
