

Whereas, the requisite qualification for selection against these posts, as per the Indent, is mentioned as under:

"Graduation from any recognised University with minimum speed of 30 words per minute in Urdu typing and diploma in Urdu Software"

Whereas, J&K Services Selection Board, conducted the Urdu Type Test and Short Hand Test for the post of Urdu Typist for which the result was declared on 22.10.2024, and accordingly, the Written Examination (OMR based) of the successful candidates for the post of Urdu Typist was conducted on 30.12.2024. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/56/2023-03(7245177) dated 17.03.2025 published the Result/Score-sheet of the candidates; and

Whereas, after the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification both at Jammu and Srinagar on 07.04.2025, followed by supplementary Document Verification on 25.04.2025; and



Whereas, the JKSSB, vide Order No.162-SSB of 2025 dated 28.05.2025, a Selection Committee was constituted for preparing the Selection List of **01 post** of Urdu Typist, Department of Law, Justice & Parliamentary Affairs; and

Whereas, the said Selection Committee, upon careful scrutiny of the Indents/advertisements, prepared the Provisional Selection List for **01 Post** in accordance with the Merit/ Eligibility of the candidates as per the extant rules and same was placed in the board in its 307th meeting, held on 01.07.2025, which after due deliberations and consideration of the matter, approved its notification.

Whereas, the provisional Selection List for the aforesaid **01 post** of Urdu Typist was accordingly, notified vide No. JKSSB-Scry/11/2025-06 (E-7704003) dated 02.07.2025, seeking objections from the candidates within a period of 10 days from the date of issuance of the notification; and

Whereas, pursuant to the above, no representation/objection was received in the Board, for the post of Urdu Typist w.r.t. withheld case, correction in particulars etc; and

Whereas, the proposal for notifying the Final Selection List, for the aforesaid **01 post** of Urdu Typist of Department of Law Justice & Parliamentary Affairs advertised vide Notification No. 05 of 2020 dated 24.12.2020, as prepared by the concerned Selection Committee, was placed in the Board in its 310th meeting held on 24.07.2025, which after due deliberation on various aspects related to the instant selection, approved its notification.

Now, therefore, the Final Selection List of the candidate for **01 post** of Urdu Typist of Department of Law Justice & Parliamentary Affairs advertised vide Notification No. 05 of 2020 dated 24.12.2020, is hereby notified as per "Annexure-A" to this Notification. It is further notified that:

- i. This Final Selection List shall be subject to outcome of the OAs/Writ Petition(s), if any, pending in the competent court of law.
- ii. This shall also be subject to the outcome of any pending inquiry, involving candidate(s), figuring in this Final Selection List.

- The Candidates(s) whose recommendations are kept withheld shall submit the iv. requisite documents/ certificates within a period of (15) fifteen days.
- The selection of the candidate has been made on the basis of Self-declaration/ certificates submitted by him and if at any stage, it comes to light that he has submitted false information or has secured selection on the basis of fake or invalid documents/ certificates, the selection shall be liable to cancellation at any stage.
