Subject: Appointment of Assistant-cum-Typist.

Reference: Advertisement Notice No. 02 of 2022 dated 06.05.2022.

University Order No.430(Est.) of 2025

- Whereas, among others, 40 posts of Assistant-cum-Typists were advertised vide Advertisement Notice No. 02 of 2022 dated 06.05.2022; and
- Whereas, 40 Assistant-cum-Typists in different categories, after following the set procedure, were offered appointment vide U.O. No. 292(Est.) of 2023 dated 05.06.2023; and
- Whereas, among other(s), 01(One) candidate in Open Merit(PwD category) didn't join on the post within the stipulated period of time, consequent upon which, one post of Assistant-cum-Typist remained unfilled; and
- Whereas, in the meanwhile, one candidate for the post(s) of Assistant-cum-Typist, filed a writ petition in the High Court of J&K and Ladakh at Srinagar titled "Shahnawaz Rashid Malla vs SKUAST-K" bearing WP(C) No.1489/2023, interalia with the prayer for directing the respondent to include the petitioner in the final selection list for the post of Assistant-cum-Typist in the Advertisement Notice No. 02 of 2022 dated 06.05.2022; and
- Whereas, Hon'ble High Court of J&K passed an interim order dated 12.06.2023, the operative part is reproduced as under:

"In the meantime, subject to objections from the other side and till next date of hearing before the bench, one post of Assistant-cum-Typist in UR category shall remain reserved for the petitioner";

- Whereas, in view of the interim direction of Hon'ble Court, one post of Assistant-cum-Typist was kept reserved; and
- Whereas, Hon'ble High Court of J&K and Ladakh at Srinagar, in the order, dated 27.05.2025, dismissed the said petition as under;

"In view of statement made by learned counsel for the petitioner, this petition is dismissed as having been rendered infructuous. Interim direction, if any, shall stand vacated."

Now, therefore, as per the merit obtained in the OMR based written test, conducted by the Controller of Examinations, SKUAST-K, Shalimar and subsequent verification of documents and ascertaining of eligibility by the designated committee and as approved by the Vice-Chancellor, Mr. Fayaz Ahmad Dar, S/o: Nazir Ahmad Dar, R/o: Chee, Anantnag-192101 is hereby appointed as Assistant-cum-Typist in Open Merit(PwD Category) on regular temporary basis in the Pre-revised Pay Band+Grade Pay of Rs.5200-20200+1900/- revised to Pay Level-2 of Rs.19,900-63,200/- plus allowances as admissible under rules. He shall report to Registrar's Office, Main Campus, SKUAST-Kashmir for further posting.

The appointment shall be governed by the following terms and conditions, that:

- a. the appointee shall join on the post within a period of 21 days of date of issuance of this appointment order, failing which the appointment shall be cancelled *ab-initio* without any further notice;
- b. the appointee shall be on probation for a period of two(02) years from the date of joining on the post;
- c. during the period of probation, the appointment can be terminated by the University any time without issuing any notice or assigning any reason(s) thereof;
- d. the appointee can be posted in any constituent unit of SKUAST-K as and when required;

- e. the service conditions of the appointee shall be governed in accordance with the SKUAST-K Statutes and rules of the University as are in force with amendments or as may come into force from time to time, together read with provisions of J&K CSR, wherever applicable;
- f. if any declaration given or information furnished by the appointee proves to be false or it is found that appointee has willfully suppressed any material information, he shall be liable for termination from service and such other action as may be deemed necessary;
- g. if any document and/or certificate submitted by the appointee is found or proved forged or fake in any way at any point of time, the appointment shall be cancelled *ab-initio* at the risk and responsibility of the concerned;
- h. the appointee shall be required to submit Medical Fitness Certificate from the Competent Authority;
- i. if upon verification, to be received from the concerned issuing authorities, to whom a reference shall be made by the concerned office, the qualification certificates and/or other documents are found to be fake/forged, the claim of the appointee for appointment as Assistant-cum-Typist shall be deemed to have been cancelled *ab-initio* and legal action as warranted under rules shall also be initiated;
- j. if the appointee has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre(DIC) and District Employment & Conselling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also the stakes, if any, in such self-employment unit/enterprise before joining the University service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and shall also personally monitor its recovery;
- k. the salary of the appointee shall not be drawn and disbursed by the respective Drawing & Disbursing Officer unless a satisfactory report in respect of condition No. (i) above are received from the concerned authorities;
- l. the appointment shall be without prejudice to the outcome of writ petition(s), if any, pending before any competent Court of Law.


