- ii. To bring about overall coordination among various implementing agencies and discharge responsibilities under the overall guidance of the Organizing/Coordination Committee.
- iii. To supervise and provide oversight vis-à-vis infrastructure development of the KIWSF-2025 venues.
- iv. To monitor the progress of the projects related to KIWSF-2025 in the field and review the work of the implementing agencies.
- v. To apprise the Organizing/Coordination Committee of all decisions of the Executive Committee from time to time, and raise all issues and concerns that may need attention of the Organizing/Coordination Committee.
- vi. To issue guidance and directions to the Games Secretariat for smooth management of the programme.
