- The candidates are required to attend, on their own expenses the document verification/ counselling/upgradation/change of stream as the case may be on stipulated date/time and venue, failing which their candidature for provisional selection/admission shall not be considered in spite of having superior claim/merit.
- The seats shall be filled strictly as per prescribed eligibility in order of merit in UET -2025 held on 01-06-2025 & 06-07-2025.
- At the time of allotment of seat during the counselling, the candidates shall have to pay in full the prescribed semester/annual fee, as indicated hereunder excluding Hostel Fee: -
