Subject: Appointment of candidates to the J&K Accounts (Gazetted) Service under direct recruitment quota through the Combined Competitive Examination, 2023.

**Government Order No.1302-JK(GAD) of 2025,
Dated:06.10.2025.**

Pursuant to the selection made on the basis of the Combined Competitive Examination-2023 and as recommended by the Jammu and Kashmir Public Service Commission, sanction is hereby accorded to the temporary appointment of the following candidates in the Jammu & Kashmir Accounts (Gazetted) Service in the pay level-8 (47600-151100), with immediate effect:

1. Ms. Damini [PSP]
D/o Arun Kumar Gupta
R/o Ward No. 9 near Old Bus

2. Mr. Rohit Kumar [OM/PHC(L)]

R/o Ward No. 1, Village Jhullas,

The appointees shall be on probation for a period of two years during which they shall undergo such training and pass the Departmental Examination as prescribed under rules.

The candidates shall report to Director General, Accounts and Treasuries, J&K and shall be allowed to join only on production of the following certificates in original:-

- (i) Qualification Certificate
- (ii) Date of Birth Certificate

- (iii) Domicile Certificate
- (iv) Relevant Category Certificate
- (v) Any other certificate required under rules.

The candidates who fail to join within a period of 21 (twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

The salary of the appointees shall be drawn and disbursed to them after the receipt of the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificates and subject to production of an affidavit (as per **Annexure-I**) to this order. In case, any candidate is adversely reported upon by the verifying agency or any certificate is found not to be genuine/valid, he/she shall have no claim to hold the post to which appointed and his/her appointment shall automatically stands cancelled without any further notice.

If any candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.

It is further ordered that for purposes of determining their seniority in accordance with Rule 24 of J&K Civil Services (Classification, Control and Appeal) Rules, they shall be deemed to have been appointed to the J&K Accounts (G) Service, notionally,

w.e.f 28.04.2025 i.e. when other candidates figuring in the select list were appointed vide Government Order No. 527-JK(GAD) of 2025 dated 28.04.2025 and regularly from the date of issuance of order. However, the deemed appointment shall not confer any monetary benefit upon them.

The appointment/allocation of the candidates to the respective service shall be subject to the outcome of the writ petition(s), pending adjudication before the Competent Court of Law, if any.

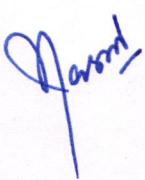

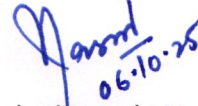
